Average duplicate record rates typically run from 5% to 20% for a single hospital facility. Complex organizations with large enrollments such as healthcare payers can experience upwards of 40% rates. Insurers frequently auto-link every member record that enters the system, creating substantial opportunity for duplication.

For today’s health insurance firms, the problems can only grow as new members flow into the system.
